

KEV KOOB PHEEJ NTAWM KEV MUAG/MUAS VAJ TSE – KEV VAJ HUAM SIB LUAG RAU SAWV DAWS

Lub Teb Chaws Asmeslivkas muaj txhua yam tsav qhia txog hais tias yuav tsum muab kev vaj huam sib luag rau sawv daws txhua leej txhua tus. Nws muaj ntaw ntawm neeg sib koom siab ua pej xeem huab hwm ua ke uas yog ib lub cim qhia txog lub ntsiab cai ntawm kev nyob ywj siab thiab kev ncajes uas yog lub hauv paus ruaj nrees ntawm lub teb chaws no. Vim li ntawd nws yog ib qho kev nyuaj siab heev thaum cov tib neeg tuaj tshiaib, cov haiv neeg tsawg, cov tsev neeg uas muaj me nyuam yaus, thiab cov neeg xiam oob khab raug kev xyeej 'es yuav/xauj tsis tau lub tsev raws siab nyiam vim kev xyeej txhem uas txhaum kev cai.

Teb Chaws Asmeslivkas Rooj Tsav Xwm Tsev Luam thiab Tsim Vaj Tse Nyob Nto Ntsis Hauv Nroog (The Department of Housing and Urban Development losyog HUD) yog tus tswj hwm Txoj Cai Tswj Kev Koob Pheej ntawm Kev Muag/Muas Vaj Tse (Fair Housing Act) uas txwv tsis pub xyeej txhem thiab hem cov neeg nyob hauv lawv tsev, koog tsev xauj, thiab koog tsev sib txuas (condominium buildings) – thiab hauv yuav luag txhua yam kev muag/muas vaj tse, ntxiv rau kev xauj thiab muag vaj tse thiab kev qiv nyiaj muas vaj tse.

Kev koob pheej ntawm kev xauj tsev thiab kev muas vaj tse yog daim lag zeb nres ces kaum tsev (cornerstone) ntawm lub teb chaws no tus txheej txhem tswj kev muag/muas vaj tse (federal housing policy). Cov tswv tsev uas xyeej neeg tsis kam xauj losyog muag tsev vim haiv neeg, xim tawv nqaj, tuaj teb chaws twg tuaj, kev ntseeg, poj niam los txiv neej, kev ua txij nkawm, losyog kev xiam oob khab yog txhaum tseem fwv txoj cai li choj, thiab HUD yuav mob siab tswj hwm thiab nplua txim rau cov tswv tsev no.

Kev xyeej txhem rau kev muag/muas vaj tse yog txhaum kev cai, tsis tas li ntawd xwb, nws txhaum lub ntsiab cai uas peb cov neeg Asmeslivkas nyiam tshaj plaws uas yog kev nyob ywj siab thiab kev vaj huam sib luag. HUD kuj mob siab los tswj hwm kom sawv daws txais kev koob pheej thaum tseem nrhiav lub vaj tse nyob.

TXOJ CAI TSWJ KEV KOOB PHEEJ NTAWM KEV MUAG/MUAS VAJ TSE (THE FAIR HOUSING ACT)

Txoj Cai Tswj Kev Koob Pheej ntawm Kev Muag/Muas Vaj Tse txwv tsis pub xyeej txhem neeg muag/muas vaj tse vim:

- Haiv Neeg losyog Xim Tawv Nqaij
- Kev Ntseeg
- Poj Niam los Txiv Neej
- Kev Xiam Oob Khab
- Kev Ua Txij Ua Nkawm (ntxiv rau cov niam/txiv losyog tus saib xyuas uas muaj me nyuam hnub nyooog 18 xyoo rov hauv; cov poj niam xeeb me nyuam thiab cov neeg tab tom yuav tau cai (securing custody) tau me nyuam hnub nyooog 18 xyoo rov hauv)
- Tuaj Teb Chaws Twg Tuaj

HAIS TXOG COV VAJ TSE DAB TSI?

Txoj Cai Tswj Kev Koob Pheej ntawm Kev Muag/Muas Vaj Tse hais txog feem ntau ntawm cov vaj tse nyob. Txoj Cai no zam cai rau qee yam xws li cov tswv tsev uas nyob hauv (owner occupied) lub tsev sib txuas tsis pub tshaj plaub lub (four units), cov tsev ib yig nyob uas muag losyog xauj 'es tsis siv tus kws lis dej num (broker), thiab tej koom haum (organizations) thiab tej pwb pab ntiag tug (private clubs) uas muaj vaj tse tsuas pub lawv cov mej zeeg los nyob hauv xwb.

TXWV DAB TSI?

Thaum Muag thiab Xauj Vaj Tse: Txwv tsis pub leej twg ua ib yam dab tsi nram qab no vim haiv neeg, xim tawv nqaij, kev ntseeg, poj niam losyog txiv neej, kev xiam oob khab, kev ua txij ua nkawm, losyog tuaj teb chaws twg tuaj:

- Tsis kam xauj losyog muag vaj tse
- Tsis kam sib hais nqi rau vaj tse
- Hais dag hais tias lub tsev tsis khoom/tsis muag
- Lwm yam kev xyeej tsis pub los nyob
- Hais cov txheej lus, txheej txheem losyog cov cai txawv thaum muag los xauj vaj tse
- Muab kev pab cuam txawv losyog tej chaw siv txawv
- Dag hais tias vaj tse tsis khoom tuaj kuaj, muag losyog xauj

- Noj tshaj thawj los ntawm kev hem los kev ntxias kom muag tsev losyog xauj tsev vim cov haiv neeg tsawg tau tsiv mus lossis tseem yuav tsiv los nyob hauv zej zos (qhov no hu ua blockbusting) losyog
- Tsis pub ib tug neeg twg nkag ua mej zeeg losyog koom nrog ib lub koom haum twg, tej chaw siv losyog kev pab cuam (xws li tso npe tawm rau ntawm qhov chaw/multiple listing service) hais txog muag los xauj tsev, losyog xyeej txhem rau ib tug neeg twg hais txog cov txheej lus lossis cov txheej txheem ntawm kev nkag ua mej zeeg losyog koom nrog.

Thaum Qiv Nyiaj Muas Vaj Tse: Txwv tsis pub leej twg ua ib yam dab tsi nram qab no vim haiv neeg, xim tawv nqaij, kev ntseeg, poj niam losyog txiv neej, kev xiam oob khab, kev ua txij ua nkawm, losyog tuaj teb chaws twg tuaj:

- Tsis kam qiv nyiaj muas vaj tse
- Tsis kam qhia txog kev qiv nyiaj yuav vaj tse
- Hais cov txheej lus losyog txheej txheem txawv thaum qiv nyiaj, zoo xws li paj laum (interest), them tus nqi paj laum ua ntej (points) losyog them nqi (fees) txawv
- Xyeej txhem thaum soj ntsuam nqi vaj tse (appraising property)
- Tsis kam yuav daim qiv nyiaj (Refuse to purchase a loan) losyog
- Hais cov txheej lus losyog txheej txheem txawv thaum yuav daim qiv nyiaj.

Tsis tas li ntawd xwb, ua tej yam nram qab no kuj txhaum:

- Hem, yuam, ua kom ntshai lossis thab leej twg uas siv tus txoj cai koob pheej ntawm kev muag/muas vaj tse losyog pab lwm tus siv lawv txoj cai no
- Hais, sau lossis luam tawm ib co lus, hais txog kev muag los xauj vaj tse, uas hais tias xaiv neeg, txo kom tsawg, losyog xyeej txhem vim haiv neeg, xim tawv nqaij, kev ntseeg, poj niam los txiv neej, kev xiam oob khab, kev ua txij ua nkawm, losyog tuaj teb chaws twg tuaj. Kev txwv tsis pub xyeej txhem hauv kev khauj tawm (discriminatory advertising) hais txog cov tsev ib yig nyob (single-family) thiab cov tsev uas tus tswv tsev nyob hauv (owner-occupied) tab txawm Txoj Cai Tswj Kev Koob Pheej ntawm Kev Muag/Muas Vaj Tse zam cai rau lwm yam

- Tsis kam muab ntawv them nyiaj pov hwm tsev (pab kas phais) vim tus tswv thiab/losyog cov neeg nyob hauv tsev hom haiv neeg, xim tawv nqaij, kev ntseeg, poj niam los txiv neej, kev xiam oob khab, kev ua txij ua nkawm, losyog tuaj teb chaws twg tuaj
- Xyeej txhem hauv cov txheej lus losyog txheej txheem ntawm tus tswv tsev cov ntawv them nyiaj pov hwm tsev vim tus tswv tsev thiab/losyog cov neeg nyob hauv tsev hom haiv neeg, xim tawv nqaij, kev ntseeg, poj niam los txiv neej, kev xiam oob khab, kev ua txij ua nkawm, losyog tuaj teb chaws twg tuaj
- Tsis kam muab tag nrho cov ncauj lus qhia txog txhua yam kev xaiv tau (coverage options) ntawm cov ntawv them nyiaj pov hwm tsev vim tus tswv tsev thiab/losyog cov neeg nyob hauv tsev hom haiv neeg, xim tawv nqaij, kev ntseeg, poj niam los txiv neej, kev xiam oob khab, kev ua txij ua nkawm, losyog tuaj teb chaws twg tuaj
- Hais, sau lossis luam tawm ib co lus, hais txog kev yuav ntawv pov hwm tsev, uas hais tias xaiv neeg, txa kom tsawg, losyog xyeej txhem vim haiv neeg, xim tawv nqaij, kev ntseeg, poj niam los txiv neej, kev xiam oob khab, kev ua txij ua nkawm, losyog tuaj teb chaws twg tuaj.

MUAJ KEV TIV THAIV NTXIV YOG KOJ XIAM OOB KHAB

Yog hais tias koj losyog ib tug nrog koj nyob:

- Xiam oob khab rau sab cev nqaij losyog lub hlwb (ntxiv rau kev lag ntseg, txav mus txav los thiab pom kev tsis zoo, mob khees xawj (cancer), puas siab puas ntsws, kab mob HIV/AIDS, losyog puas hlwb) uas tab kaum ib qho losyog ob peb qho ntawm kev ua neej nyob
- Muaj ntaub ntawv qhia txog ib qho kev xiam oob khab no losyog
- Luag xav hais tias yus xiam oob khab, txwv tsis pub ib tug tswv tsev:
 - Tsis kam cia koj muab koj lub tsev losyog chaw sawv daws siv (common use areas) txhim kho me ntsis (reasonable modifications), siv koj li nyiaj, yog hais tias tsim nyog kho rau koj siv tau tag nrho lub vaj tse. (Yog tsim nyog, ib tug

tswv tsev muaj cai cia koj txhim kho yog hais tias koj pom zoo rov kho dua li qub thaum koj tsiv tsev mus lawm.)

- Tsis kam muab kev pab kom tsim nyog (reasonable accommodations) hauv cov cai, txheej txheem, losyog kev pab cuam yog hais tias koj xav tau kev pab kom siv tau vaj tse sib luag nrog cov neeg tsis xiam oob khab.

Piv Txwv: Ib lub vaj tse uas muaj tus txoj cai txwv “tsis pub muaj tsiaj nyob hauv tsev” yuav tsum cia ib tug neeg pom kev tsis zoo yug tus aub coj kev.

Piv Txwv: Ib lub koog tsev xauj uas muaj chaw nres tsheb txaus ‘es nyias nres nyias lub tsheb qhov twg los tau mas tus tswv tsev yuav tsum tseg ib qho chaw nres tsheb rau ib tug neeg xiam oob khab (mobility-impaired) nyob ze ze rau lub tsev yog tsim nyog ua li ntawd pab nws nkag taus hauv lub tsev. Tab txawm li ntawd los xij, Txoj Cai Tswj Kev Koob Pheej ntawm Kev Muag/Muas Vaj Tse tsis tiv thaiv cov neeg uas hawv neeg kev noj qab zoo lossis kev yeej choj losyog cov neeg siv yeeb tshuaij tsis raws kev raws cai.

Teev Cov Txoj Cai ntawm Kev Nkag Taus hais txog cov Vaj Tse Muaj

Ntau Yig Nyob Hauv: Nyob hauv cov vaj tse muaj plaub yig los tshaj (4 or more units) nyob hauv thiab uas xub muaj neeg los nyob hauv ua ntej Lub Peb Hli Ntuj, Hnub Tim 13, Xyoo 1991, thiab uas muaj lub tshuab nqa neeg (elevator):

- Cov chaw qhib rau pej xeem siv (public areas) thiab cov neeg nyob hauv siv (common areas) yuav tsum kom xwv cov neeg xiam oob khab nkag taus
- Txhua lub qhov rooj thiab kev hauv tsev (hallways) yuav tsum dav txaus lub rooj zaum laub neeg (wheelchairs) nkag taus
- Txhua lub tsev yuav tsum muaj:
 - Ib txoj kev nkag taus mus hauv thiab mus dhau lub tsev
 - Cov nta teeb, qhov hluav taws xob, tus ntsuas kub/txias (thermostat) thiab lwm yam qhov tso cua sov cua txias haув tsev yuav tsum nyob ncaj kev kom xwv ncav taus yooj yim
 - Cov phab ntsa khov kho hauv chav da dej (reinforced bathroom walls) kom lwm hnub muab cov pas tuav (grab bars) ntsia rau hauv los tau thiab

- Chav ua mov noj thiab chav da dej kom xwv cov neeg zaum rooj laub siv taus.

Ib lub vaj tse uas muaj plaub yig nyob los ntau tshaj thiab tsis muaj lub tshuab nqa neeg thiab cov neeg xub los nyob hauv ua ntej Lub Peb Hli Ntuj, Hnub Tim 13, Xyoo 1991, yog hais tias zoo li no mas cov txoj cai no hais txog cov chav nyob xab ib (ground floor units) xwb.

Cov txoj cai ntawm kev nkag taus rau cov tsev muaj ntau yig nyob hauv no tsis hloov tsis pauv Lub Lav (State) losyog lub zos (local) tej kev cai uas tseem coj nruij zog.

KEV TIV THAIV RAU COV TSEV NEEG UAS MUAJ ME NYUAM

Txoj Cai Tswj Kev Koob Pheej ntawm Kev Muag/Muas Vaj Tse txwv tsis pub xyeej txhem rau ib tug neeg uas lub tsev neeg muaj ib tug me nyuam los coob tshaj uas muaj hnub nyooq 18 xyoo rov hauv (kev ua txij ua nkawm). Qhov kev tiv thaiv no muab rau cov tsev neeg muaj ib tug me nyuam los coob tshaj uas tsis muaj hnub nyooq xws li nram no:

- Nrog ib tug niam/txiv nyob;
- Nrog ib tug uas tau cai (legal custody) ntawm ib co me nyuam uas tsis muaj hnub nyooq nyob; losyog
- Nrog tus sawv cev (designee) ntawm tus niam txiv losyog tus tau cai nyob, yuav tsum muaj ntawv sau tseg los ntawm tus niam txiv losyog tus uas tau cai hais tias pom zoo tso cai rau tus sawv cev no. Kev tiv thaiv tsev neeg no muab rau cov poj niam xeeb me nyuam thiab rau ib tug neeg twg uas tseem tab tam ua ntaub ntawv tau cai coj ib tug me nyuam uas tsis muaj hnub nyooq los nyob hauv tsev (ntxiv rau cov niam txiv tshiab los adoptive parents thiab niam txiv qhua los foster parents).

Kev Zam Cai huis txog Vaj Tse rau Neeg Laus Nyob: Txoj Cai Tswj Kev Koob Pheej ntawm Kev Muag/Muas Vaj Tse txhob txwm zam cai ntawm kev xyeej txhem vim kev ua txij ua nkawm rau cov vaj tse thiab cov koog tsev rau cov neeg laus nyob. Cov vaj tse thiab koog tsev rau cov neeg laus nyob uas txais kev zam cai no ho muaj cai txwv losyog tsis kam muag lossis xauj tsev rau cov tsev neeg muaj me nyuam yaus 18 xyoo rov hauv. Yuav kom txais kev zam cai no (“housing for older persons” exemption) ib lub vaj tse

losyog koog tsev yuav tsum muaj puav pheej qhia hais tias nws cov vaj tse yog:

- Muab los ntawm Lub Lav losyog Tseem Fwv Loj txoj luag hauj lwm twg uas HUD tau pom zoo hais tias txlob txwm npaj thiab muab kev pab cuam rau cov neeg laus (raws li teev cia nyob hauv Lub Lav losyog Tseem Fwv Loj txoj luag hauj lwm); losyog
- Muab tseg rau, thiab tsuas pub neeg muaj hnub nyooog 62 xyoo rov saud los nyob xwb; losyog
- Muab tseg rau thiab khiav hauj lwm rau cov neeg muaj hnub nyooog 55 xyoo rov saud los nyob hauv.

Yuav kom txais kev zam cai rau “hnub nyooog 55 xyoo rov saud” lub vaj tse losyog cov koog tsev yuav tsum ua raws li txhua yam nram qab no:

- tsawg kawg nkaus 80 feem pua ntawm cov tsev yuav tsum muaj ib tug neeg hnub nyooog 55 xyoo rov saud los nyob hauv; thiab
- lub vaj tse losyog cov koog tsev yuav tsum khauj tawm thiab ua raws li cov txheej lus thiab txheej txheem uas qhia tawm hais tias txlob txwm khiav hauj lwm rau “cov 55 xyoo rov los saud” los nyob hauv; thiab
- lub vaj tse losyog cov koog tsev yuav tsum ua raws nraim li HUD cov txheej txheem kev cai tshuaj qhov tseeb ntawm cov neeg nyob hauv lub hnub nyooog.

Qhov kev zam cai rau “cov vaj tse rau neeg laus” tsis tiv thaiv cov vaj tse losyog koog tsev rau neeg laus ntawm yam raws cai uas yuav tau lav yog hais tias xyeej txhem neeg vim haiv neeg, xim tawv nqaij, kev ntseeg, poj niam los txiv neej, kev xiam oob khab, losyog tuaj teb chaws twg tuaj.

HUD nyob no npaj txhij pab daws yam teeb meem twg hais txog kev xyeej txhem rau kev nrhiav vaj tse. Yog koj xav hais tias luag txhaum koj txoj cai lawm, koj muaj peev xwm xa ntawv liam txog kev txhaum koj txoj cai rau peb siv hluav taws xob (online), sau tsab ntawv xa tuaj losyog hu xov tooj tuaj rau HUD qhov chaw ua hauj lwm nyob ze tshaj rau koj. Koj muaj ib lub xyoos xwb kom yuav tsum xa ntawv liam tuaj qhia tom qab uas qhov kev xyeej txhem txhaum ntawd tshwm sim, tab sis mas koj yuav tau fi xov tuaj sai li sai tau.

YOG KOJ XAV TIAS LUAG TXHAUM KOJ TXOJ CAI LAWM

Yuav Qhia Dab Tsi rau HUD:

- Koj lub npe thiab qhov chaw nyob
- Lub npe thiab qhov chaw nyob ntawm tus neeg txhaum koj (tus neeg raug liam “respondent”)
- Qhov chaw nyob thiab lwm yam qhia txog lub vaj tse uas muaj teeb meem ntawd
- Ib zaj lus piav txog qhov kev txhaum ntawd (muaj dab tsi tshwm sim ua rau koj xav tias luag txhaum koj txoj cai)
- Lub hnub tim los cov hnub tim thaum luag txhaum koj.

Xa Ntawv Mus Iosyog Hu Xov Tooq Qhov Twg: Xa ntawv liam txog kev txhaum koj txoj cai rau peb siv hluav taws xob (online), sau tsab ntawv xa tuaj rau HUD qhov chaw ua hauj lwm nyob ze tshaj rau koj, los yog koj xav, cia li hu xov tooj ncaj qha rau lub chaw ua hauj lwm ntawd. 
